Annapolis Parade - July 4th 6:30

pm (Amos Garrett Blvd., right on West Street, around Church Circle, down Main Street, left on Randall Street, and ends in front of the Market House).

NO DUMPING!

The Board has received numerous complaints about the unsightly debris being dumped behind residents' fences and in the community's common areas. Some

NO DUMPING ALLOWED

residents have been using the area outside of their fence, along tree lines and common area woods to discard their unwanted items such as trash, old lawn mowers, appliances, yard debris, lumber, etc. Everyone is reminded that it is illegal and against our covenants to use community common areas as their personal dumping ground. Action will be taken against those who violate our covenants by the continued dumping of unwanted items on the community common areas.

News from the Board of Directors

At its recent meetings in April and June, the following topics were discussed:

Visitor Parking Spaces. Residents continue to use visitor parking spaces (and other resident's parking spaces). If residents have more than two vehicles per household, they cannot park in visitor parking spaces nor in other residents' parking spaces without permission. They must park either along the curb (not a yellow curb), in designated parking areas on our private streets or on Walnut Ridge Drive.



- Rodent Infestation. The report returned by the pest control company indicated that Community's biggest problems are: (1) the improper storage and disposal of trash (trash should always be stored in **secure** trash receptacles and not stored in plastic bags), (2) attention to bird feeder maintenance/spilled bird seed, (3) improper disposal of pet waste, (4) dumping of trash particularly along the wood line, and (5) storage of junk and debris under and around decks. All of these attract rodents and give rodents a place to nest. These problems must be addressed by residents before a pest control company will be contracted.
- Spring Walk Through Inspections. CIS HOA Inspection Experts will be conducting Spring inspections beginning in mid-June.
- Contractor's Corner. Handyman/contractor suggestions will be considered for sharing with other residents by way of the newsletter and website.
- No Dumping Signs. Are now located throughout the community on common areas.
- **Storm Cleanup.** Proposals are being considered for the cleanup of various common area tree damage / downed trees caused by recent storms. Damaged trees will be trimmed or removed.
- **A&E Applications.** Discussion of several A&E Applications which were submitted to the Board.
- Quarterly Assessments. Attention to homeowner assessment arrearages.

Save the Dates!

Walnut Ridge is participating in the Anne Arundel County Community Clean-up Program. A dumpster is tentatively scheduled to be available in the Cul-De-Sac by 12 noon on Friday, September 7, and will be picked up by 2:30 pm on Saturday, September 8, 2018. In accordance with the AA County Community Clean-Up Guidelines, do not place items outside of the dumpster, or place prohibited items in the dumpster. The dumpster will be monitored for misuse, so please do not abuse this privilege.



Do NOT place any of the below items in the dumpster: hazardous waste, junk automobiles, trailers, boats, gas and propane tanks, tires, oil drums or tanks, paint, liquids, refrigerators or air conditioners. For the proper disposal of the prohibited items mentioned above, please call the County (410) 222-6108.

SCOOP THE POOP

An estimated 1.3 million dogs live, play and poop in Maryland. Picking up after your dog's waste is important for your health, the health of your pet and Maryland's environment. The simple act of picking up after your dog



by "scooping the poop" can assist in removing harmful nutrients and bacteria from local waterways and the Chesapeake Bay, keep our citizens healthy and our yards and shoes clean.

Dog waste is an environmental pollutant. Decaying pet waste consumes oxygen and sometimes releases ammonia. Low oxygen levels and ammonia can damage the health of fish and other aquatic life. Additionally, pet waste carries bacteria, viruses and parasites that can threaten the health of humans and wildlife. Since storm drains do not always connect to treatment facilities, untreated animal feces often ends up in rivers and streams, causing significant water pollution and in some cases restrictions on fishing and swimming in waterways and beaches.

Home Improvement Approval Reminder!

Summer weather has many residents thinking about sprucing up the exterior of their homes.



If you have plans to make improvements which will affect the **physical appearance** of the exterior of your home, please be reminded that an A&E Application **must be submitted** to the Board for review and approval **before** work begins. The two-page A&E Application has a checklist of documents which must be included with your application. Those documents are (in addition to the Application):

- Two (2) fully-completed copies of the application.
- Self-addressed, stamped envelope (please ensure adequate postage).
- Site plans, elevations and sketches and plat with dimension.
- Completed (unapproved) Building Permit (if required).
- Manufacturer's literature of photographs of similar projects (if applicable).
- Landlord's written consent (if applicable).
- Any other pertinent, supporting information.

You'll find the Application Form on our website at www.walnutridgeonline.org and click on A&E Standards.

It is imperative that you obtain approval **before** you begin exterior improvements. This includes painting and replacement of windows, doors or roof.

You will want to avoid a situation where improvements have been made ahead of approval, then subsequently disallowed and would then require corrective action.

- Your Community's assigned spray night is: Wednesday
 - Your community will only ever by sprayed on Wednesday nights during the 2018 season
- Spraying can occur anytime between 7:00 PM and 2:30 AM
 - The spray program will begin on May 30.
 - Spraying will not begin until the community has been notified and we have received the Community Notification Verification Form
 - October 2 is the estimated last day of spraying for 2018

STANDARD MOSQUITO CONTROL OPERATING PROCEDURES - 2018

OPERATING PROCEDURES FOR SPRAYING OF ADULTICIDES (Treatment for adult mosquitoes):

- Regular Surveillance and Control of Adult Mosquitoes: May 30 October 2 Sunday-Thursday (A night of the week will be assigned to your community) Anytime between 7:00p.m. - 2:30 a.m.
- Spraying for adult mosquitoes will be done only if a Maryland Department of Agriculture Employee determines it is necessary.
 - Spraying will not be conducted during rain, in wind speeds exceeding 12 MPH, or temperatures above 89°F.
 - Thresholds for Ground Based ULV Treatments:

Landing Counts: 3 mosquitoes in a 2 minute count

Light Trap Collections: 12 female mosquitoes in an unbaited light trap
 24 female mosquitoes in a baited light trap

Conditions that threaten public health, such as mosquito borne disease

Adulticide Formulation and application rate

Permanone 30-30: Liquid

Permethrin mixed with Piperonyl Butoxide 0.0031 lbs/acre (Ultra Low Volume application)

and Mineral Oil

OPERATING PROCEDURES FOR USE OF LARVICIDES (Treatment for mosquito larvae):

 County-wide Surveillance and Control of Larval Mosquitoes: April - October Monday – Friday, 8:30 AM -4:00 PM

LARVICIDES TO BE USED (This list is subject to additions or other revisions):

Larvicide Formulations

Bacterial Larvicides:

VectoBac and Aquabac:

Bacillus thuringiensis var. israelensis Liquid, Granular

Spheratax:

Bacillus sphaericus Granular

<u>Insect growth regulator</u>:

Altosid (Methoprene) Liquid, Briquet, or Pellets

- The Mosquito Control Program does not spray for Midges that swarm on homes, boats, trees and shrubs along many Anne Arundel County creeks and rivers. These non-biting insects develop in mud bottoms of slow moving water ways of low dissolved oxygen and will decline in numbers within a few weeks after they first appear.

MOSQUITO CONTROL POLICY STATEMENT

OBJECTION TO ADULT MOSQUITO CONTROL

The policy of the Maryland Department of Agriculture regarding an objection to adult mosquito control by truck-mounted ultra low volume (ULV) application of insecticides is as follows:

- ! An individual may have his/her owned or leased real property and a surrounding buffer up to 300 feet on all sides of the property excluded from ground based ULV adult mosquito control.
- ! Each individual requesting this exclusion must submit the request in writing to the Maryland Department of Agriculture and provide copies to the appropriate community association or city/town. The request must provide the address of the property to be excluded and must be signed by the owner(s) or leasee(s). This request will be acknowledged in writing by the Department.
- ! If the number of individual objectors and the location of excluded properties precludes an effective mosquito control adulticide service in a community, the service in that community will be suspended. Service may be reinstated upon the written request of the community and approval by the Department.
- ! A city/town or community association may request the Department to rescind or modify a spray exclusion zone if the local authority believes the exemption unfairly impacts other residents who desire adult mosquito control service. Requests to rescind or modify spray exclusion requests must be made in writing and delivered to the Secretary of Agriculture.
- ! The Department periodically will verify the continued occupancy/ownership by objectors of properties excluded from ULV ground spraying to determine if the objection continues.
- ! In the event of mosquito-borne disease or conditions that threaten public health, the suspension of mosquito adulticide service in an area due to objectors will be discontinued and the full range of mosquito control procedures available will be utilized.

PUBLIC INFORMATION NOTICE:

Your **request for exemption from adult mosquito control services** by the Maryland Department of Agriculture **WILL NOT** be processed unless **ALL** of the information requested has been supplied. You have a right to inspect, amend, or correct this information. Under State Government Article, 10-617, Annotated Code of Maryland, this information may be generally available for public inspection. This information is not routinely shared with state, federal, or local government agencies.

REQUEST FOR EXEMPTION FROM ADULT MOSQUITO CONTROL SERVICES

This application must be completed by the individual residing within a community participating in the Mosquito Control Program who wishes to have his/her property excluded from adult mosquito control pesticide applications by truck-mounted ultra low volume (ULV) sprayers. The attached statement entitled "Objection to Adult Mosquito Control" explains the Maryland Department of Agriculture's policy on individual objectors. Please retain it for your files.

Please complete all information below. Please read the "Public Information Notice" on the attached policy statement. Exemptions will not be accepted unless all of the information requested has been supplied. Failure to respond to contact from MDA will result in the voiding of your exception. It is your responsibility to notify MDA should your contact information change. Thank you for your cooperation in this matter.
